- December 2016: 2016 UCAS end of cycle data released
- 2016-2021: Research Excellence Framework and Stern Report
- 2016 Higher Education and Research Bill
- 2017 Sir David Bell UUK review of sector agencies

### What is Workload Management?

- 1. Workload Management Framework (Model; Allocation Process; Data/platform/reports)
- 2. Aim to align resource with strategy (Corporate/Unit Plan)
- 3. Benefits of WLM?
  - Enabling the best match between Faculty and School strategic objectives and the staff resource
  - Making the allocation of workload more transparent so as to build trust between staff members within a unit, foster understanding and respect for differing individual contributions to the School or Faculty, and improve morale.
  - Linking workload allocation with the professional and career aspirations of individuals
  - Helping the School to support its Health and Safety responsibilities through planning and allocating manageable staff workloads to prevent excessive stress for individuals
  - Contributing to supporting the equality and diversity obligations of the School, for example, by addressing issues of parity of treatment for staff on fractional contracts
  - Assisting planning through the provision of management information to senior management

- 2. Provider written submission narrative

# How WLM can be used as a planning tool to improve performance in the TEF

- 1. Alignment of resource with strategy
- 2. Evidence allocation of resource to support TEF in provider narrative submission
- 3. Learning and teaching strategy examples:
  - Assessment and feedback
  - Scholarly activity
  - TEF connected AML
  - Student support advising
  - Enhancing the student experience
- 4. Costings
- 5. Incentivising TEF related activities
- 5. Staff plan (REF and TEF)
